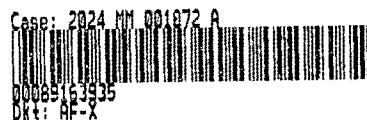

The victim had an obviously fresh laceration to his left eye brow consistent with the alleged events.

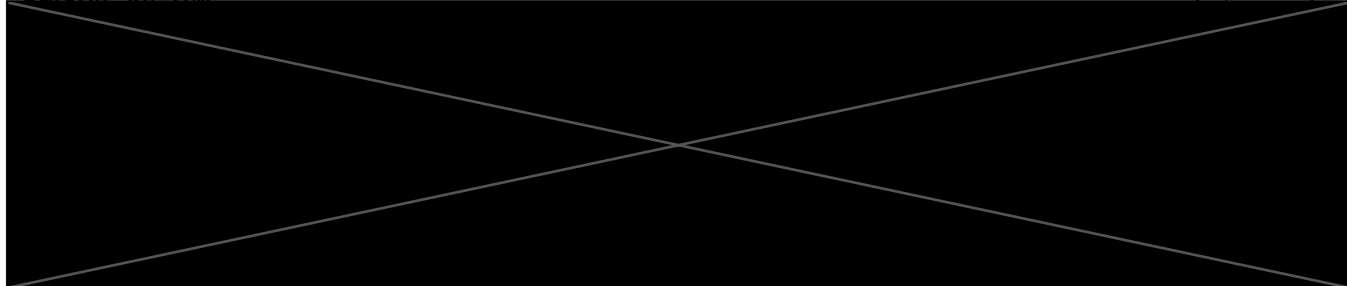
The suspect maliciously and intentionally grabbed the victim and shoved him causing the victim to strike his head on the corner of the air vent causing a minor injury.
