PROSECUTIVE SUMMARY - CONTINUED

the DEF threw a red/clear glass vase at VIC1 causing the vase to shatter. It is unknown if the vase struck VIC1. VIC2 who was sitting up to get off the couch was struck on the center of her back and her upper left arm by the flying broken glass causing small visible scrapes. VIC2 then ran into the back bedroom with her mom and sister who did not witness the incident but only heard glass breaking and some yelling.

The DEF and VIC1 were both heavily under the influence of alcohol and refused to provide LEO with any statements about the altercation. The DEF and VIC1 both had numerous cuts/scrapes all over their bodies. The condition of the residence and VIC2's injuries were consistent with VIC2's statements who witnessed most of the altercation before running into the bedroom.

Post Miranda, the DEF told LEO to figure it out and that there was nothing to talk about because he fights with his brother all the time.

I positively identified the DEF via his FL ID.
