PROSECUTIVE SUMMARY

The DEF then shoved the VIC against the wall and forced the VIC to sit in a chair. The DEF began screaming at the VIC, while grabbing the VIC's face in the chin/neck area.

The VIC was able to eventually separate from the DEF with the assistance of several staff members.

The DEF was escorted out of the building by staff, left the area and was not located.

LEO observed this incident on a camera located just outside of the computer room through the open door.

The VIC and DEF have been in a dating relationship for the last 2 months.

The VIC did not sustain any visible injuries.

The DEF was positively identified by the VIC.

The DEF has 1 prior domestic battery conviction out of Sumter County Sheriffs Office (602017MM001127MMAXMX).
