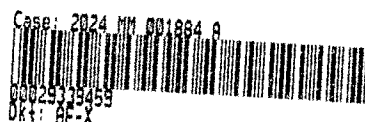

approximately ten years and reside together as a family unit making this incident domestic in nature. The DEFENDANT did intentionally and actually touch the VICTIM against his will, to wit;

On September 16, 2024 at approximately 1110 hours, I responded to [REDACTED] in reference to a domestic battery. The VICTIM called into the combined communications center stating his husband (DEFENDANT) put his hands on him.

The VICTIM and DEFENDANT were in an argument over a handmade bowl being used for their cat's water dish. The DEFENDANT and VICTIM were both sitting in separate chairs at the time of the verbal altercation. The argument continued when the DEFENDANT threw some potato chips near the VICTIM. The VICTIM stood up and approached the DEFENDANT when the DEFENDANT then spit at the VICTIM. The DEFENDANT proceeded to push the VICTIM with open hands in the chest area.

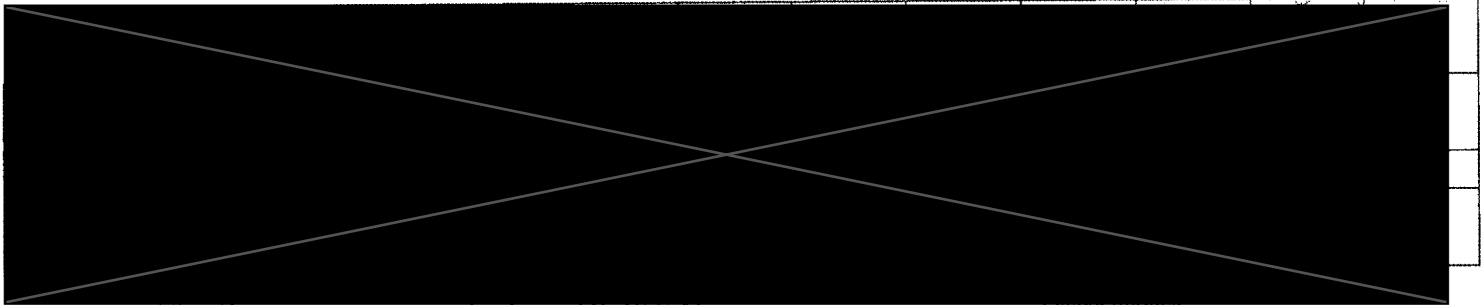
I observed potato chips on the floor in the office area of where the altercation occurred which corroborates the VICTIM'S story. Post Miranda the DEFENDANT admitted to throwing potato chips, spitting at, and shoving the VICTIM.



