The following investigation occurred within the Alachua County Department of the Jail, which is within Alachua County,

Florida. All calls related to this investigation were made using the Securus Communications system. All calls placed by inmates have a pre-recorded message telling the inmates and the person called that the calls are being monitored and recorded. All calls in this investigation were captured for evidentiary value.

On February 21, 2024 the defendant CHRISTIAN EUGENE THOMPSON, was arrested and booked in the Alachua County jail on court case 01-2024-CF-637-A for Obstruct/Hinder 911 communication, Robbery by Sudden Snatching, False Imprisonment, Aggravated Assault with deadly weapon, Aggravated Battery with a deadly weapon, and Battery (Domestic). This case involved multiple stab wounds to the victim from the defendant after being imprisoned for over twelve hours.

On February 22, 2024 the defendant appeared at First Appearance before the Honorable Thomas Jaworski and was ordered to have no contact with the victim, [REDACTED].

This investigation revealed that between February 22, 2024 to August 26, 2024, the defendant used another inmate's PIN (personal identification number) to contact the victim directly eleven (11) times. During these calls, the defendant apologized for his actions in the above case, but then contradicted his statements when he told the victim that he didn't do anything to hurt her and would cut her off when she attempted to speak about the case, likely due to the defendant's knowledge of the recorded call and that he was using another pin number to place the call. All of these calls took place between August 03 and August 14, 2024. The defendant's identity was also confirmed using the jail surveillance cameras within the housing unit.

The defendant is being charged with eleven (11) counts of Violation of Pre-Trial Release conditions, specifically to have no contact with the victim.

Due to the defendant not adhering to the order of the court, and the extreme mental and physical violence displayed in the case, this Detective respectfully requests that PHONE AND VIDEO VISITS BE RESTRICTED to attorney use only.


