involved with their neighbor and forcibly grabbed the VIC's phone out of her hands and smashed it against the wall. He advised she would not be calling for help and refused to let her call her job, where she was expected to go to work at 1500 hours. Instead, the DEF forced the VIC to strip out of her clothing and get into the closet for "time out" while he berated her, threatened her, and physically attacked her. The DEF called her job from his phone to let them know that she would not be going to work that day and told the VIC that he would harm her or her family members if she attempted to call for help or get away from him.

The DEF placed her broken phone and multiple of her clothing items (valued at \$500) into a trash bag and she never saw those items again.

Over the next several hours and into the early morning hours of January 24th, the DEF struck the VIC in the face with his hands, struck the VIC all over the back and legs with a broken table leg and broom, and poured water he heated up in the microwave for 6 minutes onto her bare feet. When he saw that she was bleeding from a wound under her left eye, he made her get into the shower and rinse the blood off. He then resumed beating her and advised he did not "feel like [he had] done enough" to her.

He retrieved a fixed-blade knife from the kitchen and returned to the bedroom and began stabbing the bed repeatedly. While doing so, he described what stabbing a person does to them and ordered the VIC to explain what human sacrifice means. He began to smile and laugh as she defined human sacrifice and told her he was about to show her "what human sacrifices are."

The DEF then stood over the VIC in the closet and threatened to stab her in the neck. He said that if she screamed she was "going to be dead." The VIC tried to grab the knife and the DEF stabbed her in her right hand. He then stabbed her multiple times in her left thigh and knee.

Immediately following the stabbing, at approx. 0400 hours on January 24th, upon realizing how much the VIC was bleeding, the DEF agreed to call 911. However, the DEF instructed the VIC to leave the apartment and to lie about what happened or he would harm her mother and shoot up her home. Both of them then told the responding officers that they had been robbed by two unknown suspects. The DEF additionally told officers that he and the VIC are cousins and that the reason the DEF was not injured in the robbery was because he ran and one of the unknown suspects shot at him. The VIC denied that any shots were fired and there was no evidence of shell casings in the area. There was also not a knife or other physical evidence of the fight or stabbing in the area they described the attack.

After being released from the hospital, the VIC did not return home and changed her phone number so the DEF could not contact her. She believed the DEF had returned to their apartment despite him not being on the lease. She remained in fear that the DEF would find her and cause harm to her or her family, so she did not come forward to YA about what happened until her mother helped her clean out her apartment over the weekend of February 17 and 18th.

Her mother observed several slices and puncture marks in the VIC's mattress and asked the VIC what happened. The VIC admitted the DEF was the one who had stabbed her and that

it happened in their apartment. The VIC called YA on Sunday (February 18) and then again Monday (February 19) to explain what had actually occurred and why she had been too afraid to share it before.

On the morning of February 19, YA responded to the VIC's apartment with GPD forensic investigators. We observed several stab marks in the VIC's mattress and sheets, several holes in the drywall, a portion of the carpet that had been ripped up, and what appeared to be a bloody handprint in the shower. Additionally, through the use of a blood reagent, the FCU investigators revealed a significant quantity of blood that had been cleaned up from the carpet at the foot of the bed, the laminent flooring inside the VIC's bedroom door, and in the shower and shower drain. This is all consistent with the VIC's statements and with the apartment being the original crime scene.

On February 19, the VIC met with YA for a follow up interview where she described all of the events that had occurred. She also explained a pattern of physical abuse with the DEF and that she had tried to get him to find a new place to live, but he refused. The VIC stated the night of February 23rd into February 24th, she thought she was going to die that night.

The DEF was positively identified by the VIC from a single DL photo.
