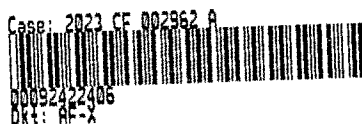

On September 20, 2023 at approximately 0247 hours, I responded to [REDACTED] Street in reference to a Domestic

Battery call for service.

I arrived and [REDACTED] came to my patrol vehicle visibly upset, [REDACTED] stated her and her boyfriend who she resides with, Michael Washington, had gotten into a verbal altercation. [REDACTED] stated Washington confronted her after accusing her of infidelity. [REDACTED] stated Washington got in her face and [REDACTED] said she pushed him in an attempt to gain distance from him. [REDACTED] stated after she pushed Washington, Washington held her down and put her in a headlock. [REDACTED] stated in an attempt to fight Washington off she scratched his neck. I observed blood on [REDACTED]'s dress and when I asked about the blood, [REDACTED] stated she cut it on the door attempting to get out of the house.

I spoke with Washington and read Washington his Miranda Rights. Post Miranda initially Washington advised the argument was only verbal. Washington then stated [REDACTED] pushed him 3 times inside of the residence and Washington stated he did not touch her. Washington's story then changed to [REDACTED] had pushed him 3 times inside the residence and started to gather her clothing off of the couch and there was an empty can and a knife on the couch where she cut her finger. Washington then advised [REDACTED] was pushing him and Washington stated he brought [REDACTED] to the ground in an attempt to defend himself. When I asked Washington about his injuries a final time, Washington reverted back to stating [REDACTED] pushed him and he did not touch [REDACTED].

I observed a scratch on Washington's neck and a scrape on Washington's left arm. When asked where the injuries came from, Washington initially said the scratch on his neck was from [REDACTED] pushing him and the scrape on his arm was from [REDACTED] scratching him. Washington then changed his story and stated he could not advise where the cut on his neck came from and the scrape on his arm was from the metal railing on the steps on the front of the residence. The metal railing does not appear to have any sharp edges and appears to have smooth edges on the side.

Deputies located a dirt area on the side of the residence that had dirt which was disturbed and appeared like a physical altercation had occurred in this area.

After Washington was placed in handcuffs we became angry, yelling at [REDACTED] stating when he got out of [REDACTED] he was going to kill her.
