PROBABLE CAUSE

On 6/4/2020, I responded to [REDACTED] N US 441 to meet with victim TRISA NEELON who called the Alachua County Sheriff's Office to report that her husband JESSY WESTBERRY had battered her. The incident took place at [REDACTED] Street which is in the limits of Alachua County.

The investigation reveal that victim [REDACTED] and the defendant JESSY have been in a domestic relationship for the past eight (8) years. The two have been married for two (2) years, have four (4) children in common and have been living together as a family on and off for the past five (5) years. [REDACTED] and JESSY got involved in a verbal argument after the [REDACTED] asked JESSY to help her with the kids. JESSY got upset at the [REDACTED]'s request and during the argument JESSY hit [REDACTED] twice in the forehead. The first hit was to the left side of [REDACTED]'s forehead and the second to the right side. [REDACTED] was unable to say whether JESSY used an open hand or closed fist. [REDACTED] did have a small area of redness on the left side of her forehead in the area [REDACTED] indicated she was [REDACTED].

I responded to the location where the incident occurred in an attempt to make contact with JESSY, however, he had left the location [REDACTED] to my arrival.
