On 09/09/2024 I responded to the area of 29000 West Newberry Road in refence to a disturbance.

I arrived on scene and made contact with VICTIM, [REDACTED]. the VICTIM was at the time assisting with traffic control as the roadway was under construction. The VICTIM was assigned a post clearly marked with traffic cones and had a STOP / SLOW sign he was utilizing to allow vehicles to pass through the area. The VICTIM sated the DEFENDANT, Dallas Williams JR arrived at the VICTIMS post and started to argue due to not being able to drive through the roadway. The VICTIM stated during the argument the DEFENDANT exited his vehicle, pulled the front of his pants open and exposed his penis. The VICTIM stated the DEFENDANT yelled "look at this sh*t" while exposing himself. The DEFENDANT then got back into his vehicle and left the scene where he was later stopped by deputies. The VICTIM stated he was offended by the action and wished to pursue charges.

David Connors who was on scene working with the VICTIM also observed the DEFENDANT expose himself. David did not wish to pursue charges for the act.

Post miranda the DEFENDANT stated he pulled his pants out instead of down and did not expose his penis. The DEFENDANT demonstrated this action to deputy's on scene. The action performed by the DEFENDANT again exposed himself. The DEFENDANT also stated to have told the VICTIM to "suck my d**k". The DEFENDANT ultimately denied exposing himself during the argument.

Due to the DEFENDANT exposing his penis to the VCTIM the DEFENDANT is charged with exposure of sexual organ (FSS 800.03.1a).
