On above date and time, the complainant (store LPO) reviewed surveillance video and observed the DEF enter the store and fill a shopping cart with various bottles of bug spray, large jugs of concentrated Round-up weed killer, Dewalt pressure washer, and Dewalt backpack pump sprayer (total stolen \$885.34). The DEF then exited all points of sale without paying for the items through the garden entrance and ran into the parking lot with the shopping cart.

During this time, VIC1 (customer) observed the DEF run outside and she followed him to a

PROSECUTIVE SUMMARY CONTINUED	<p>red Nissan Pathfinder (FL tag #PIVQ45) where she saw the DEF unload several items into the vehicle. The VIC took a cell phone photo of both the license plate and of the DEF which angered him and caused him to attack her. The DEF was recorded on store surveillance video and on cell phone photos grabbing the VIC (67yrs old) and violently pushing her down onto the pavement. This caused several visible injuries to the VIC to include bruising and red bleeding scrapes with peeled skin along her left arm, elbow, left leg and left knee all which required first aid and bandages.</p> <p>WIT1 (customer) advised he was standing in the parking lot at a distance and observed the suspect run towards a red Nissan SUV and then attack the VIC and push her down. WIT1 took photos of the suspect and called 911 for help. The registered owner of the vehicle advised her brother (WIT2 Nelson) was driving her car all day. WIT2 eventually made phone contact with me and admitted he drove the car, the DEF (friend) gave him gas money, he picked the DEF up from the Grace Market Shelter (3055 NE 28th Dr), and he drove the DEF to Home Depot. WIT2 said he took a quick nap inside the car and waited for the DEF to get done shopping. WIT2 denied any knowledge of the theft nor the battery in the parking lot. WIT2 said he woke up hearing the DEF jumping into the passenger seat yelling 'Go, Go, Go.' WIT2 said he returned the DEF back to Grace Market who took the property with him and he has not heard from the DEF since. WIT2 said he personally knew the DEF, provided the DEF's name, and identified him by a photo.</p> <p>I submitted Williams' photos to CID SGT Ferrara for a facial recognition request who advised the photos most likely matched Mark Williams (DEF). I researched the DEF who also had police report history at Grace Market one of which the DEF was charged with giving false information with the name of Michael Nelson similar to WIT2's name, see CR</p>
