I arrived on scene and made contact with [REDACTED] who stated her son, DEFENDANT Michael Washington had pushed a female while within an outside gazebo. [REDACTED] was heavily intoxicated and could only provide that information. I then made contact with the VICTIM, [REDACTED] and witness [REDACTED] on the property. The VICTIM stated the DEFENDANT got angry at [REDACTED] and attempted to throw a beer in her direction. The beer can hit the ground and [REDACTED] attempted to exit the gazebo. The DEFENDANT then stood up from his chair and motioned towards [REDACTED]. The VICTIM stated she grabbed [REDACTED] to move her from the DEFENDANTS path when the DEFENDANT wrapped his arm around her arm and pushed her. [REDACTED] stated she was within the gazebo when the battery occurred and both parties went into a secondary structure on the property.

I made contact with the DEFENDANT on the property. It is to be noted that the DEFENDANT was also heavily intoxicated at time of contact. Post miranda the DEFENDANT stated he stood up from his chair and threw his beer on the ground. The DEFENDANT stated he did not touch anyone while inside of the gazebo.

The DEFENDANT has three prior battery convictions (012003MM011877 / 022006MM001255 and 012008MM0074192). Due to multiple statements from witnesses on scene that a battery occurred the DEFENDANT is being charged with felony battery (FSS 784.03.2).
