On the above date and time at the above location the Vic arrived at the residence she shares with the Def. The Vic and Def had previously been at Munegins Bar but left separately after a verbal argument. The Def arrived home before the Vic and was waiting in the driveway when she returned. As the Vic walked up the driveway the Def confronted her and pushed her. The push caused her to fall on the sloped driveway and hit her head on the concrete. As a result of being pushed and hitting her head the Vic sustained an approximate 2-3 inch laceration on the right side of her head which required 3 staples to close. The Vic's injury will result in a permanent visible scar.

PROSECUTIVE SUMMARY - CONTINUED
The Vic also stated that she was being treated for a concussion.
After the Vic got up she went inside the residence where the Wit was. The Witness stated that the Def followed the Vic inside and was still aggressive toward her to the point he had to physically stand between the Vic and Def to keep him from her again.
The Vic stated that the Def "bum rushed" her as she was walking up the driveway and she did not want to be pushed by the Def. The Vic and Def have been in a relationship for approximately 7 years, live at the above location as a family, and share one child in common.
Post Miranda the Def stated that when the Vic came home she got upset and pushed him. He stated that he retaliated and pushed her back and they both fell onto the driveway. He stated that he was not injured.
Of note, the Def is 12 inches taller than the Vic and outweighs her by approximately 200lbs.
