On Friday, 07/26/24, at approximately 1841 hours, GPD officers who observed a traffic violation (Stop Bar Violation & suspicion of illegal tint) conducted a traffic stop on a black 2017 Infiniti Q50S bearing a 2024 FL tag of 67EIPV (VIN JN1FV7AP0HM850119) at the 1000 block of NE 2nd St. Officers conducting the traffic stop were in a clearly marked uniform and driving a clearly marked patrol SUV with agency insignia prominently displayed. Officers initiated the traffic stop by activating their overhead emergency lights (blue and red LEDs) and siren. The black Infiniti stopped on NE 10th Ave just west of its intersection with NE 2nd St.

PROSECUTIVE SUMMARY CONTINUED

As officers approached the Infiniti on foot, it hastily departed from the traffic stop at a high rate of speed westbound on NE 10th Ave. The officers conducting the traffic stop returned to their vehicle and turned off their patrol vehicle's overhead emergency lights.

A short time later, the Infiniti was involved in a traffic crash (documented under CR 02-24-010991) at the intersection of NW 10th Ave and NW 6th St. This traffic crash resulted in traffic fatality from the other vehicle and the Infiniti's four occupants, including the DEF, being transported for emergency medical treatment on an assortment of injuries including fractures and lacerations. VIC 2 suffered a Traumatic Brain Injury, is intubated and not likely to survive.

Upon the Infiniti coming to rest at the front yard of 626 NW 10th Ave, the DEF (later identified as the driver by WIT 1), ran from the scene of the traffic crash without offering any aid to the occupants of either vehicle. Despite suffering from an apparent broken ankle, the DEF ran from the scene and attempted to hide in the yard of a nearby property (307 NW 11th Ave). After a perimeter was set up and a suspect description was broadcast, the DEF was located by a GPD K9 officer conducting a K9 track. The DEF was taken into custody without further incident. When taken into custody, the DEF had visible swelling on his ankle and was unable to walk without assistance. The DEF was later admitted for further evaluation/treatment at UF Shands.

In addition to independent witnesses (WIT2 & WIT3) to the crash identifying the DEF as the driver who limped from the scene, a passenger (WIT1) in the Infiniti also identified
