of age. The two children were in close enough proximity to their mother to be exposed to the DEF who was actively exposing his penis to her.

VIC4, who is an employee at Jersey Mikes, stated he was outside assisting with a door dash order, when he also witnessed the DEF exposing his genitals to people as they passed by him (it appeared as if the DEF was exposing himself towards women).

VIC5, who is also an employee at Jersey Mikes, stated that she was also outside assisting with an order, when the DEF walked up to her and had his penis in his hand (his pants were down). She stated the DEF then began smiling at her, and starting intentionally shaking his penis around for her to see.

WIT1, who is a law enforcement officer employed with GPD, also witnessed this entire incident from inside of the store. WIT1 witnessed the DEF expose himself and confirmed by sight that he was actively pulling his pants down, fully exposing his genitals to citizens (this information was broadcasted over the radio prior to arrival).

After the DEF was located sitting in front of the business, he was handcuffed. When I handcuffed the DEF, his pants were halfway down his thighs, with his penis being barely covered by a piece of cloth (part of his boxers).

The DEF provided me on scene with the name of "Cela Lama Jala DOB 01/05/1994". That name did not receive any returns through teletype, and I did not receive any results from MCT or DAVID when searched. Once booked into ASO DOJ, he was identified as "Cecil Jackson DOB 01/05/1994". The DEF intentionally provided me with a false name during my investigation, and refused to speak with me any further about the incident.

The DEF was identified by VIC1, VIC2, VIC3, VIC4, VIC5, WIT1, and LEO through DAVID (after confirming his real identity).
