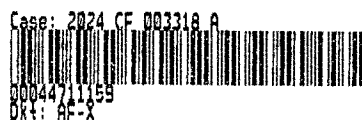

Probable Cause

On this date the Defendant and Victim were at the Victim's residence. The Defendant and Victim were engaged in an argument when the Victim told the Defendant to leave her residence. After the Defendant left the residence, the Defendant returned and told the Victim to give him a watch that he left at the home. The Victim didn't know what the Defendant wanted. The Defendant then knowingly and intentionally entered the curtilage (Attached Covered Porch) of the Victims residence and began to kick the door causing damage estimated at \$200. The Defendant kicked the door so hard

that it caused the door to open. When the door opened the Victim was in fear for her safety and the Safety of her 8-month-old child. The Victim stated that the Defendant began to walk toward her in the doorway after the door opened. The Victim was in such fear for her safety that she armed herself with a .380 caliber Glock pistol and fired a single warning shot into the ground away from the Defendants location. The Defendant then fled the area by getting a ride from the Neighbor of the Victim. The Defendant was located shortly after and admitted to being on the property and to being told to leave by the Victim. The Victim provided a sworn written statement outlining the events that occurred on this date.

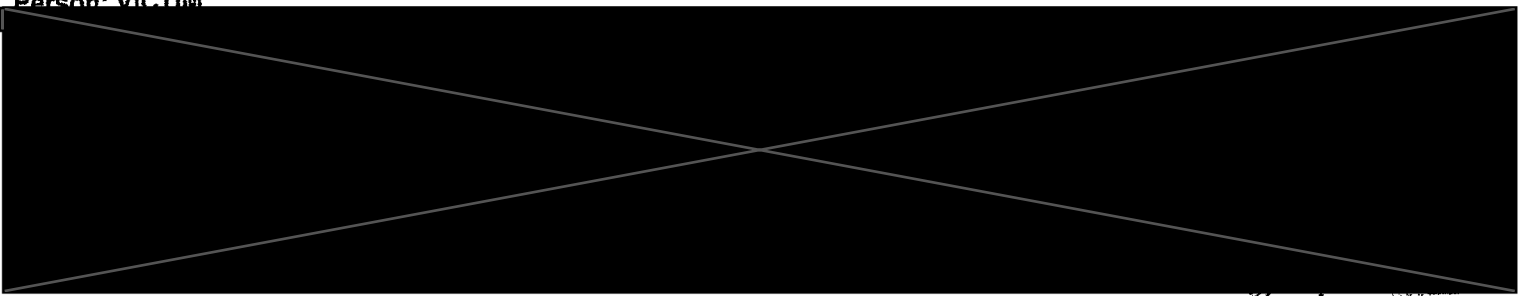
The Defendant had two large bags of items when he was arrested. His items were searched and multiple knives and contraband were removed roadside. Upon entry into the secured portion of the jail, DOJ personnel conducted another search of the Defendants backpack. DOJ staff located a small brass Derringer size antique black powder pistol in a pocket that wasn't located during the roadside search. As the Pistol was being removed from the backpack, the Defendant stated oh that's pre-1900 gun. The firearm was manufactured after 1971 when the Brand CVA (Connecticut Valley Arms Inc.) began manufacturing firearms. The Defendant failed to notify deputies that the firearm was in his backpack prior to entry into the correctional facility and was subsequently charged with Introduction of a firearm into the Alachua County Jail.

The Defendant is also a convicted felon and was in possession of a firearm. The Defendants last felony conviction was on January 23, 2006 for Grand Theft. The case number for this conviction is 01CF2004003738.
