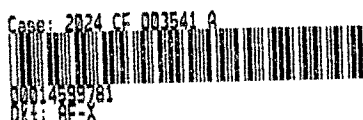

Probable Cause

On the incident date and time, I responded to a report of assault in Archer. I observed the Defendant, Quinell Thompson, standing on the side of the road, and [REDACTED] standing on the other side. The call listed Mr. Thompson as the suspect so I attempted to make contact with him first. Mr. Thompson immediately started yelling at me, telling me, I should not be talking to him first because he didn't call. I was wearing my uniform of the day complete with ACSO insignia to include my badge and patches. I gave a lawful order to Mr. Thompson to come and talk with me and he refused. I ordered him to stop and he kept walking. I then drew my Taser and ordered him to get against the truck which was in the yard. Mr. Thompson complied and I detained him in handcuffs.

Following his arrest for resisting without violence, Mr. Thompson was pulling away from me when I escorted him to my truck. I decided to put him in the ASO marked patrol vehicle at which point Mr. Thompson intentionally struck me with his elbow causing me to bleed by knocking the knuckle of my right ring finger and pinky finger into my uniform tools.

I made contact with the Victim, [REDACTED] and the witness, [REDACTED] they both stated that Mr. Thompson became upset because he did not like what [REDACTED] was doing with Ms. [REDACTED]'s leaves. They both stated that Mr. Thompson threatened to beat up Ms. [REDACTED] while he was between 6 and 12 feet of Ms. [REDACTED] and advancing towards her, placing her in a well founded fear that he was going to follow through with his threats and cause her harm.

Photos were taken of my injuries and there is body worn camera footage of Mr. Thompson's attack on me.


