Video surveillance was obtained from the management office. The video shows the VIC approaching the DEF outside room 435. The VIC is seen waving her arms and pointing at the DEF. The DEF then approaches the VIC and shoves her 3 times into a vehicle.

Post Miranda the DEF stated he pushed the VIC because she was being aggressive and "was getting up in his face".

The VIC had no visible marks on her person.

The DEF was identified by his DAVID photo.
