**Probable Cause**

The DEFENDANT, Tyrin Young, did intentionally and maliciously commit the act of domestic battery and battery by strangulation, when he struck the VICTIM, [REDACTED] in her face. The DEFENDANT then strangled the VICTIM during their altercation. The VICTIM and the DEFENDANT have been in an intimate relationship for several months making this dating violence and domestic in nature.

My investigation revealed that on September 21<sup>st</sup>, 2024 at approximately 0450 hours, the DEFENDANT and the VICTIM were at the DEFENDANT's apartment for the evening. The DEFENDANT had an argument with the VICTIM, which ended with the DEFENDANT going to his bedroom, and the VICTIM remaining in the living room area. The VICTIM wanted to get rest on the couch, so she decided to go to the bedroom where the DEFENDANT was lying in the bed, and retrieve his blanket. The VICTIM walked inside the DEFENDANT's bedroom and grabbed the blanket on the bed and went back to the living room. The VICTIM got on the couch and a short time later, the DEFENDANT walked out of his bedroom and confronted the VICTIM, as she laid on the couch.

The DEFENDANT grabbed the blanket and attempted to pull it away from the VICTIM. Both the blanket and the VICTIM's underwear were in the DEFENDANT's grasp at that moment. The DEFENDANT began to drag the VICTIM across the living room, towards the bedroom by her underwear. The DEFENDANT attempted to have the DEFENDANT relinquish his grasp on the blanket, due to him tearing the material on her underwear. The DEFENDANT then released his grasp at the entrance of the bedroom door. The DEFENDANT took an aggressive stance towards the VICTIM. He then raised his clenched fist, giving the VICTIM the assumption that the DEFENDANT was about to strike her. The VICTIM then placed the blanket over her face, in an effort to absorb the strike from the DEFENDANT. The DEFENDANT then struck the VICTIM in her face, causing her immediate pain and discomfort to her lips.

The VICTIM removed the blanket from her facial area and noticed that the DEFENDANT was still standing over her. The DEFENDANT then placed both his hands on the VICTIM's neck and throat area, and began to squeeze in an effort to strangle the VICTIM. As the DEFENDANT was squeezing the VICTIM's neck he stated "STOP PLAYING WITH ME STUPID ASS BITCH"! The DEFENDANT began to impede the VICTIM's airway and her normal breathing. The VICTIM then lost consciousness and believed that was the reason that the DEFENDANT released his grasp on her neck. When she regained consciousness, the DEFENDANT was still standing over her, and stated to her "YOU GONE STOP FUCKING PLAYING WITH ME"! The DEFENDANT then walked over to his bed and laid down and the VICTIM walked to the bathroom to see her injuries.

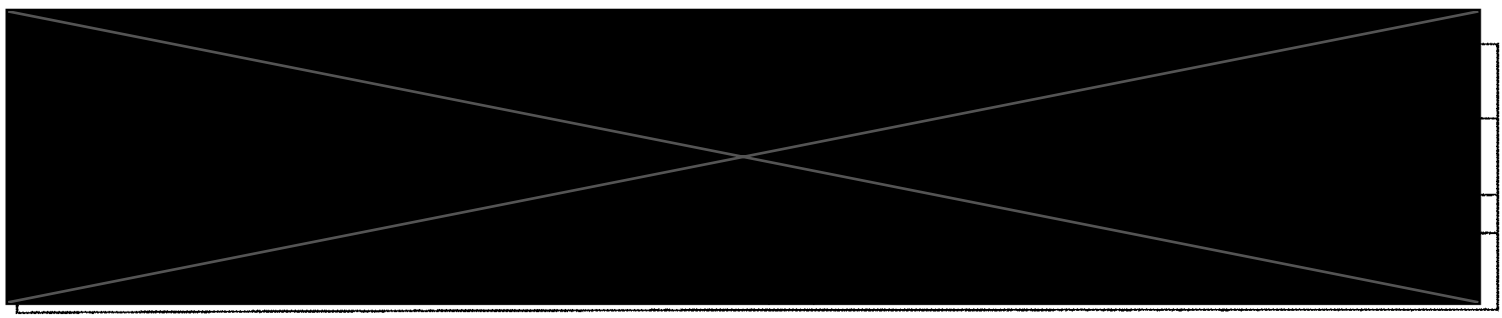
The VICTIM allowed me to view the pictures on her cellphone during the interview. The image was timestamped for September 21<sup>st</sup>, 2024 at 0458 hours. The image was a selfie taking by the VICTIM. The VICTIM had severe swelling to her lips and she had several red marks on her neck. The injuries shown in this picture was consistent with the account given by the VICTIM.

Post Miranda, the DEFENDANT refused to give a statement and asked for a lawyer.

Based on my investigation, the DEFENDANT is being charged with battery and Battery by strangulation. He is currently incarcerated due to another on-going battery case involving the VICTIM. ASOCR24-008764. The DEFENDANT doesn't have any prior battery convictions.
