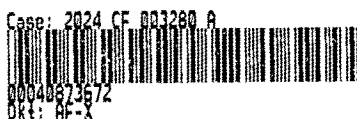

(Linton Oaks) in regards to a call for service where a neighbor called 911 due to a "incident" taking place in Apt

Upon arrival on scene, Deputy Miller could hear a male and female inside of the apartment, specifically the female could be heard crying. Deputy Miller stated he heard the female state "he tried to kill me". Deputies contacted Capers Douglas Jr who initially opened the door and then tried to close the door while  was still inside the residence with him. Capers was not allowed to close the door and detained pending the on-going battery investigation.

The investigation revealed that Capers and  have known one another for approximately 8 years and have been in an on/off dating relationship for that time period.

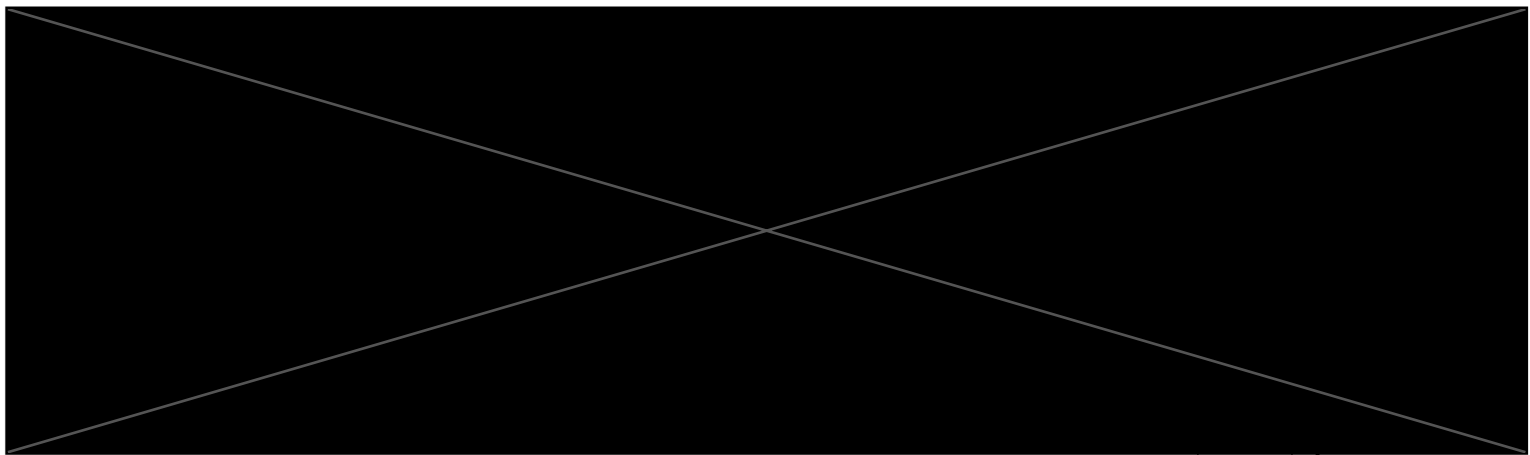
At approximately 0100 hours, on 10-02-2024, Capers told  that he wanted to have sex with her.  declined the offer to have sex as she is 3 weeks pregnant which upset Capers.  explained that Capers became violent with her after he declined to have sex with him. Capers grabbed  by her arm, pinned it behind her back by twisting it and pushing her against the bedroom wall.  then claimed that Capers placed her on the ground, straddled her body and placed his two hands around her neck and strangled her which prevented her from breathing normally.  stated that she was placed onto the bed, he straddled her body a second time, placed his two hands around her neck and strangled her which prevented her from breathing normally.

stated to Deputies that she has been a victim of battery at the hands of Capers for several years. During that time, Capers has resorted to physical violence to include the attempted sexual battery of her person which both have occurred on multiple different occasions.

Capers has at least five prior battery convictions in the State of Florida. Capers was placed under arrest and is being charged with two counts of FSS 784.031.1- Domestic Battery by strangulation.


