I ordered DEF to get on the ground, so that he could be handcuffed, DEF refused to do so, and stated "no". I then tried to physically place DEF into handcuffs from behind, to which he actively resisted by pulling his hands away from me and placing them in front of him to prevent himself from being placed in handcuffs.
