agency issued body camera footage from the date of the initial report and based on my observations, the victim is visibly pregnant and it would be obvious to the defendant that the victim is pregnant.

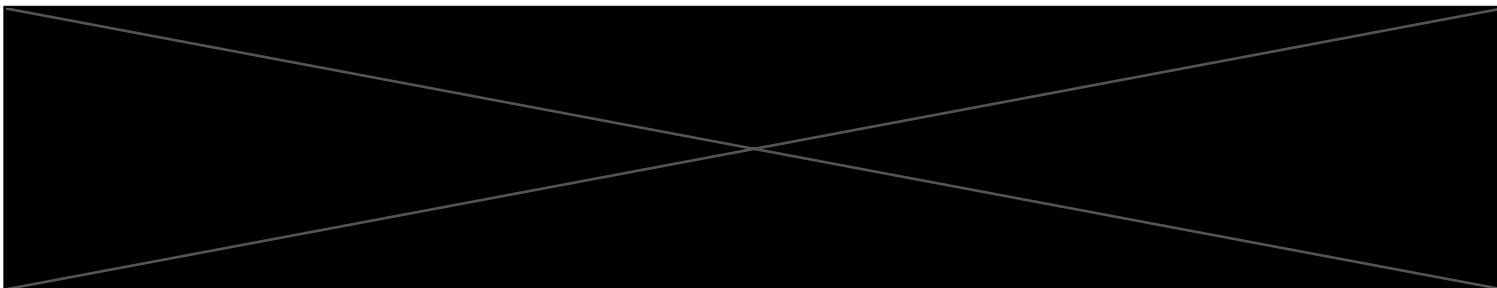
I made contact with the victim, [REDACTED]. The Victim stated that her boyfriend and father of her unborn child, the Defendant, Montravious Brazil, struck her in the face with a shoe and bit her on her fingers during an altercation. The Victim is approximately 7 months pregnant and co-habitates with the Defendant. The Victim stated the argument was over the defendant accusing her of talking with men on her cell phone which he grabbed from her when she tried to call her mother. The Victim stated that after the Defendant struck her he ran downstairs where he threw her phone on the ground before leaving the scene.

I made contact with the Witness, [REDACTED] who is the victim's mother and who lives downstairs from the couple. Ms. Baldree stated that she heard the argument as they were coming down the stairs and she told the defendant to give back her daughters phone which is when he threw it on the ground.

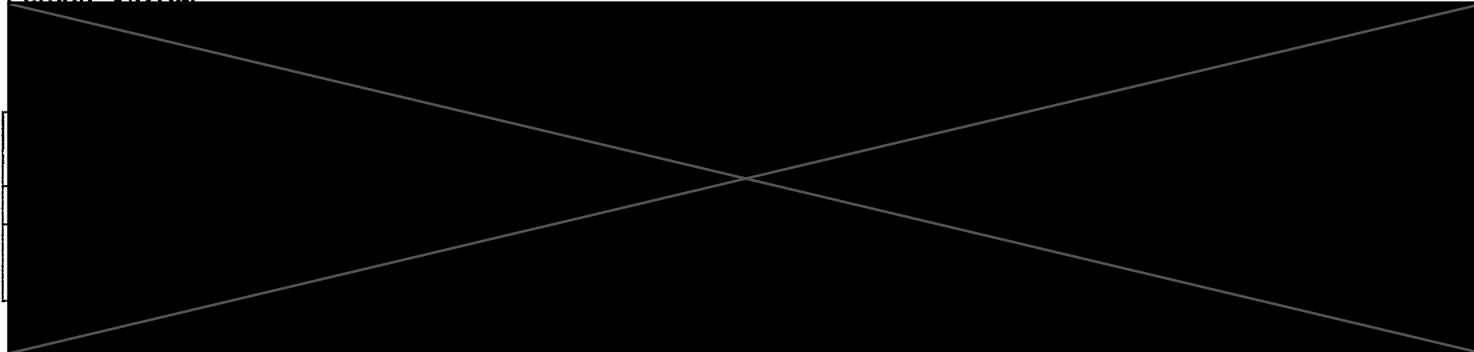
I photographed the victim's injuries which included two scratches to the left side of her face from the shoe, and a bite mark on her fingers, one of which was bleeding. I also photographed the drops of blood in her apartment which went from the entrance to the master bed room. The Victim described the shoe as being a white and yellow Jordan tennis shoe. The Victim stated the Defendant took the shoes with him.

Units searched the area for the Defendant however he could not be located. The Victim could not advise where he might be located at.



