The DEF tapped the VIC's shoulder and when the VIC told the DEF not to touch her, the DEF began acting erratic. The DEF took out a pocketknife and told the VIC "tell whoever you got to, I'll kill you". The VIC was in fear for her life began moving away from the DEF and getting onto the bus that just arrived. While the VIC was trying to get away from the DEF, the DEF lunged at her with the knife in his hand, positioned as if he was getting ready to stab her. The VIC was able to block the DEF by using her forearm to protect herself and hitting the DEF's forearm, so she wouldn't get

PROSECUTIVE SUMMARY cut. The VIC was still pushed onto the bus, by the DEF, due to his stabbing attempt. WIT1 who is a RTS Bus Driver, then closed the bus doors locking the DEF out, to keep the DEF from stabbing the VIC. The DEF then fled the area on foot. WIT2 who is the VIC's nephew was standing near the VIC when this incident occurred.

While heading to the incident location I noticed the DEF walking west, on SE 4th Ave, towards SE 2nd St. While attempting to turn my patrol vehicle around, the DEF fled upon sight of my police vehicle and began running south in between houses and cut through multiple yards. I exited my vehicle and began running after the DEF in full police uniform. I gave the DEF lawful commands to stop running multiple times, in which he continued to run away from law enforcement. WIT3 advised he saw the DEF running east bound near the 500 block of SE 3rd St. Ofc. Rico, Ofc. Jin, and I tracked with Cpl. Walsh and K-9 Stern. We apprehended the DEF at the 500 block of SE 3rd St. While placing the DEF in handcuffs, The DEF was ordered to lay down and I observed a large pocketknife approximately 5-7 inches long near the DEF's right side of his body.

WIT1 and the VIC positively identified the DEF via Show Up.

I made contact with WIT1 who confirmed while the VIC was sitting on the bus bench, the DEF began yelling at her "You can talk about me, tell whoever you gotta tell", and brandished a pocketknife approximately 3 inches long. WIT1 advised the DEF kept approaching the VIC as she was backing away onto the bus, when the DEF attempted to cut the VIC with the knife, and pushed the VIC onto the bus. WIT1 demonstrated the VIC's blocking motion to prevent the DEF from stabbing her, when the DEF lunged at her. WIT1 advised he then closed the bus doors, locking the DEF out. WIT1 advised the DEF yelled

"I will cut you", before attempting to stab the VIC. WIT2 confirmed WIT1's account.

PROSECUTIVE SUMMARY - CONTINUED
Ofc. Jin read the DEF his Miranda Rights, and the DEF invoked his rights with me. The DEF admitted to Cpl. Walsh to pulling out a knife on the VIC, but advised "he wasn't going to do anything with it". While driving to ASO DOJ, the DEF spontaneously uttered "I'm sorry for what I did", and "Why I did that shit man". The DEF then asked if he was going to jail because he ran from me, and when I told him it was regarding the incident at the bus stop, the DEF uttered "the knife".

I transported the DEF to ASO DOJ without incident.

The DEF has no previous battery convictions.

I identified the DEF by his FL ID.
