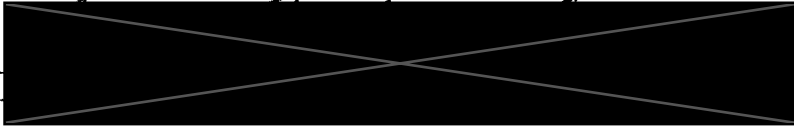

ORDER APPOINTING PUBLIC DEFENDER


