#### Update on CTAC funding

On August 12, the Children's Trust of Alachua County Board approved the rollover of \$250,000 from fiscal year 24 (FY24) to the FY 25 budget, which resulted in a total of \$500,000 for the FY 25 budget. We are continuing conversations with CTAC to develop a plan for review in September.

#### **Program Updates**

IMPACT GNV summer updates included information on the B.O.L.D. Program, Willie Mae Stokes Center, Crisis De-escalation Classes, Gun Lock Blitz, and the County Small Grants Program Updates.

One Nation, One Project GNV held its final event. More than 750 attendees joined at the Cotton Club Museum and Cultural Center and Depot Part for the summer YOUth! Celebration.

The youth steering committee will present (will have presented, by the time you read this) their gun violence analysis and solutions to the Gainesville City Commission on August 15. The committee is currently in transition. The application process is under review, flyers and marketing for new member recruitment are under development.

#### Organizational values

- Action-oriented.
- Community Engagement
- Ethical.
- Importance of relationships within communities.
- Inclusive.

- · Locally based, in some form

- Respectful of the individuals impacted as important stakeholders in the process.

#### What should community engagement look like?

- All ages, but youth have a seat at the table.
- Be representative of the community and include engagement.
- · Hands-on: get your hands dirty.
- Have food available.
- In person and online.
- In the community: churches, schools.
- Transportation provided.
- Victims and survivors involved.

#### Types of past experience and clients

- Examples of fundraising for similar initiatives.
- Examples of successes, not just plans, specifically with young people.
- Health department access/community experience and outreach.
- Judicial experience.
- Mental health focus.
- Past experience working with other government entities and other non-profits (community organizations).
- Research and data driven.
- Social issues.
- The right target audience.
- Understands Gainesville and North Central Florida.
- Victim services.
- Wealth, public health model.

#### Stakeholder Announcements

Santa Fe College (SF) Chief of Police, Ed Book, shared the story and pictures of the Youth Forum held at SF on August 9 for justice-involved youth. Many community organizations participated in this event and served about 25 youth. The event was generously funded by the Children's Trust of Alachua County with in-kind funding from participating partners. The youth each received a "passport" in which they collected stamps after every activity. If they collected all the available stamps, they received community service hours credit for the day.
