Video surveillance clearly showed the DEF exposing his penis to the VIC while it was flaccid at the register. Video showed the DEF coming back to the register a second time and intentionally exposing his penis to the VIC, fully erected. At the ending of the video, the DEF is seen staring into the business from the outside, through a glass window at the VIC.

The VIC stated the DEF is a regular customer and comes in often. The VIC stated the DEF attempted to make contact with her a third time, to apologize for his actions. The VIC told the DEF to leave the store. The VIC identified the DEF by photo line-up.

After a routine Teletype inquiry, the Teletype operator ID 223 advised the DEF was convicted of Incident Exposure of Sexual Organs (Misdemeanor) on 12/23/2014. (Reference Court Case Number - 012014MM004244A)

With this information, I confirmed via LINDAS the DEF had a guilty adjudication for the listed court case.

This is the DEF'S second subsequent offense of Incedent Exposure of Sexual Organs and it would make this a 3rd degree felony.
