On October 27, 2023, [REDACTED] went to Simon's Night Club with her friends for an evening out. On her way to the night club she received a text message from the DEFENDANT stating he was at the club. Additionally, the DEFENDANT told [REDACTED] he paid for a private area of the club for her and her friends. [REDACTED] and the DEFENDANT had a pleasant evening at the night club until they left at approximately 0145 hours on October 28, 2023. As [REDACTED] and the DEFENDANT walked to their own vehicles an argument transpired, at which time they both left in separate directions.

As [REDACTED] was driving home, she received multiple calls from the front gate of her residence, which indicated someone was trying to enter the complex and it was the DEFENDANT. When [REDACTED] arrived at her apartment complex, she observed the DEFENDANT's black truck parked across the street at Tires Plus Service Center. [REDACTED] walked upstairs to her apartment and observed visible damage to her door frame and the front door open to her apartment; the DEFENDANT was standing in the living room. [REDACTED] confronted the DEFENDANT as to why he was in her apartment without her permission, at which time he took control of [REDACTED]'s neck and took her to the floor on her back against her will; this occurred near the dining area of the apartment. While [REDACTED] was on her back, the DEFENDANT kneeled on top of her and strangled her until she almost lost consciousness. The DEFENDANT released his grip from [REDACTED]'s neck and stepped back near the counter top. [REDACTED] was able to get up from the floor, retrieve her vehicle key and flee to her mother's residence in [REDACTED] County, Florida.

During my interview with [REDACTED] she explained when she arrived home and noticed the DEFENDANT in her apartment, her apartment was in disarray. [REDACTED] said while she was on her back being strangled, she gasped for air and was unable to yell. [REDACTED]'s vision became impaired and she said, "I saw stars." [REDACTED] further explained she remembered thinking about her child, and that she was going to "Lose her life for nothing." When [REDACTED] returned to her apartment with her mother at approximately 1015 hours, her personal items were thrown over the balcony of her apartment. [REDACTED]'s Apple iPhone, iPad, Apple Watch, and Apple air pods were also missing from the apartment and could not be located.

Deputy Sheriff's located the DEFENDANT at [REDACTED] and he was read his Miranda Right's. The DEFENDANT told deputies he did meet with [REDACTED] at Simon's Night Club and they had an argument. The DEFENDANT also advised deputies he was heavily intoxicated and remembered parking his truck across the street from [REDACTED]'s residence, but was unable to remember going inside her apartment.

The DEFENDANT entered the structure located at [REDACTED] Gainesville, Alachua County, Florida leased by [REDACTED]. The DEFENDANT does not reside at the apartment, nor did he have permission to be at the apartment. The DEFENDANT entered the apartment by kicking the front door open which caused damage to the door frame. Once inside the residence, the DEFENDANT scattered her belongings around the residence, also throwing items over her balcony. When [REDACTED]

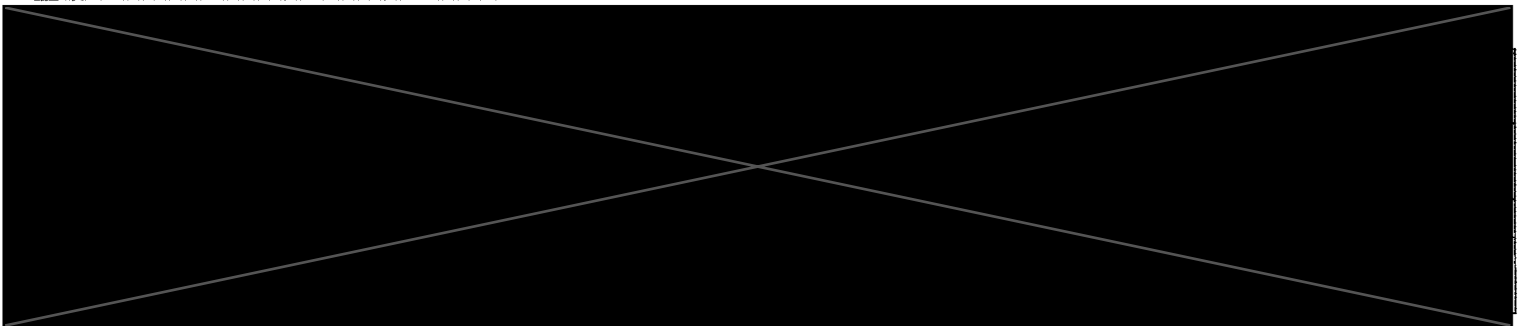

arrived home, the DEFENDANT knowingly and intentionally impeded the normal breathing of [REDACTED] against her will, by applying pressure on the throat of [REDACTED]. Additionally, when [REDACTED] returned home from the incident with her mother, her Apple iPhone, Apple watch, iPad, and air pods were missing and could not be located.

The DEFENDANT has been charged with Burglary of an Unoccupied Dwelling per FSS 810.02(3)(b), Domestic Battery by Strangulation per FSS 784.031(1), Grand Theft \$750.00 Less Than 5K per FSS 812.014(2)(c)(1), and Criminal Mischief for the damage to the door per FSS 806.13.(1)(b)(2).
