Whereas, Barbara White, County Court Officer has made an oath that, Amos Rushing, hereinafter referred to as the aforesaid was on the 4th day of June A.D., 2024 placed on probation for Offense of CT.I: Battery: Touch or Strike (Domestic); CT.II: RESIST OFFICER-OBSTRUCT WO VIOLENCE in the County Court of Alachua County, Florida, for a term 12 months, in accordance with the provisions of Chapter 948, Florida Statutes, and that the aforesaid has not properly conducted himself, but has Violated the Conditions of his Probation in a material respect by:

Violation of General condition, which states, "Live and remain at liberty without violating any laws."

On 12/06/2024, a Sworn Complaint was filed by Gainesville Police Department Officer Autis Gibson #1191 for case #01-2024-MM-002534-A: Battery: Touch or Strike (Domestic)

Violation of Special Condition, which states, "Pay \$50.00 per month Level II Cost of Supervision to the Department of Court Services."

The probationer has a balance of \$600.00 for Cost of Supervision fees.

Violation of Special Condition, which states, "Enroll within 45 days and successfully complete the Batter's Intervention Program with no unexcused absences. Provide proof of successful completion to your supervisor. Complete within the first year of probation."

To date, the probationer has not provided proof of completing 19 of 29 Batters' Intervention sessions as of 11/29/2024.

Violation of General Condition, which states, "Pay \$678.00 for Fines and Court Costs."

To date, the probationer has a balance of \$615.20 for Fines and Court Costs.

The Court, therefore, commands you to Arrest instanter Amos Rushing and bring him before this Court to be dealt with according to law.
