PROSECUTIVE SUMMARY - CONTINUED  
Then on the evening of 2/23/25 WIT and VIC saw several anti-Semitic post on Instagram by DEF who was now tagging VIC in the anti-Semitic posts. DEF posted images of a person around what appears to be a bonfire with the caption "The Jews watching Jesus come back after they K\*llled him" followed by tagging VIC's Instagram handle stating "this dumbass jit is so fucked... Do uk how many of ur brothers this retard jumped just to look cool? Lets teach this jit a lesson". DEF also posted a photo of VIC with the caption "Imma torture this snitchass nigga in hell... I burned eight billion to take off my chains" DEF also posted an image with the caption "look up in the sky, 10 is on the way" and again tagged VIC in the post stating "good job retard you pissed off a royal bloodline im gonna fucking torture you eternally if you don't apologize and bend before me". DEF also posted a portion of his face and again tagged VIC, stating "oopsies look like u pissed off a mason! Watch ur back my army watches". DEF also direct messaged WIT stating " is gay af lol! Tell him to find me at mid this week! Im torturing that nigga in hell!"  
VIC stated this is not the first time DEF located him and simulated shooting him with a gun and that he has been dealing with DEF's anti-Semitic remarks for the last several years, since he met DEF during his college freshman year. VIC further advised some of the images posted during DEF's online rant are used to promote the anti-Semitic theology.  
VIC stated due to DEF's actions and statements, he is in fear for his safety and, as a result, resulted in VIC having severe mental anguish from the events of the hate crime. VIC advised DEF could soon follow through in attempting to harm VIC due to DEF's level of escalation in recent days.
