I am writing to formally request the removal of the Prosecutor / Assistant State Attorney, and State Investigator from my ongoing case (Case Number, 01-2024-CF-002347-A). I have significant concerns about their impartiality, due to previous threats made against me, and their handling of the matter over the past two years,

Throughout the course of this case, I have faced several incidents that have raised doubts about the fairness of the process. Specifically: my rights, laws to protect me and personal safety, I am disabled and in need of medical treatment and meds I am unable to receive.

- 1) A History of Faults accusations against me since Feb 15<sup>th</sup> when [REDACTED] went to Jail for pulling and pointing a gun on me and threatening me if I was still at the house when she returned she would shoot me in my chest. Which she gave GPD her maiden name [REDACTED] but was married and legally [REDACTED]
- 2) Times I have called GPD for assistance due to assaults by [REDACTED] and was told no arrest would be made and asked did I have some where else to go.
- 3) Being threatened by her family and my personal belongings thrown away and destroyed and told because she was my wife she had the right to do so.
- 4) 30 days before July 8<sup>th</sup> on June 8<sup>th</sup> [REDACTED] called 911 and stated I took her phone GPD responded to the home and she was told it wasn't a crime for her husband to have or look in her phone the crime was if I prevented her from calling 911 in a emergency and 30 days later she called and told GPD just that after I left the home which I have a witness she texted them while him and I was on the phone after I left the home.(All public records)
- 5) All this is a attempt to discredit me as a Father to get full custody of our child and if the 3 divorces she has filed in the last two years can be reviewed it will show the malicious intent behavior displayed by [REDACTED] and her unbalanced mental ways it's a game she has played in 2 different marriages and 3 Fathers of her 3 kids.
- 6) [REDACTED] has been contacting me via Zoom 3 days a week agreed between the two of us in mediation in civil divorce for a 15 min meeting on the behalf of our child which she requested to say on more then once for max time of 30 mins and even to long back on as long as 1 1/2 hours and stopped on 16<sup>th</sup> of Oct to turn around and contact me on Oct 21<sup>st</sup> in the early morning to wish me a Happy birthday and to have a great day and any other time she has something to say.Sending me her NEW cash app and saying I can send her money if I choose to.

There have been instances where the police, the state's attorney and investigator have displayed clear bias against me, which I believe has influenced the direction of this case. The handling of evidence, and communication with me and other witnesses, suggests an unwillingness to approach the matter and evidence objectively. For example, there is a supplemental report and body cam footage taken by Officer Henry's supervisor, Sgt. Postle. Sgt. Postle agreed that officer Henry did not do a proper investigation and outlined exactly what steps she should have taken on the night of the incident. I was more than willing to cooperate with the investigation in person, but after having brief phone contact with me, Ofc. Henry stated that I was not cooperative and simply filed a sworn complaint in lieu of doing her own proper investigation. I have text message evidence of my conversation with Ofc. Henry where I was clearly communicating and giving her evidence (photos) that she never included in the report. This evidence, combined with a phone interview that was completed by the State's Attorney after-the-fact should be more than enough to show that I was improperly charged.

I have been subjected to actual threats from these individuals, which has created an environment of intimidation. These threats not only affect my peace of mind but also raise serious concerns about the integrity of the investigation and prosecution. As I have had open conversations with Both the other 3 times [REDACTED] has abandon the home and marriage and removed our child and made false accusations against me to people in the community but never reported it with any form of Law enforcement where I have fought to report and get support based off Florida Laws to get told walk away. Let it Go we are not going to touch that I have documentation and videos with meetings with Law enforcement.

Over the last two years, [REDACTED] and State Investigator Don Tonya Smith have both made false statements and false accusations against me, which have damaged my reputation in the community.

My wife, [REDACTED] (aka [REDACTED] aka [REDACTED] has engaged in a predictable pattern of behavior where she leaves our home, takes our child, and then makes false accusations in order to try to manipulate the legal system to keep me from seeing our child. This is behavior is now being aided by State Investigator Don Tonya Smith, Who has a Personal relationship with [REDACTED] and History with myself and my family

I have tried to pursue legal recourse every time [REDACTED] has left our home with our child, but was threatened by Prosecution Attorney and Don Tonya Smith to "let it go," and to be careful of what "boats I rock."

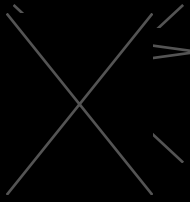
