WHEREAS, Ann-Marie Brown has made oath that on the 11th day of April, A.D. 2011 one Carl Dennis Stewart, hereinafter referred to as the offender, was placed on sex offender probation for the offense of Ct.1: Engaging in Sexual Activity with a child 12-18 yoa. in the Circuit Court of Alachua County, for a term of 15 years state prison followed by 15 years of Sex Offender Probation in accordance with the provisions of chapter 948, Florida Statutes, and that the offender has not properly conducted himself, but has violated the conditions of his sex offender probation in a material respect by:
