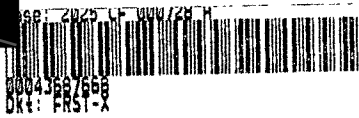
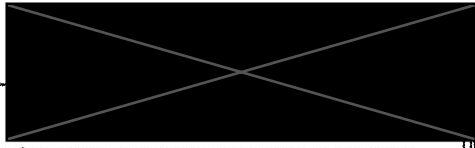

ORDER APPOINTING PUBLIC DEFENDER


