## **Probable Cause**

On April 17<sup>th</sup> 2025 at approximately 2139 hour's, I conducted a traffic stop on a Red Toyota Camry bearing Florida registration 60BZUD (registered to Erica R. Hall, DOB 09/21/1982) for running the red light at SR93/W Newberry RD while traveling east bound on W Newberry RD.

Upon contact with the driver and sole occupant of the vehicle (Jeramey Prince Delapierre, DOB 06/23/1986, B/M), he provided a copy of his valid class E Florida's driver's license. While conducting enforcement action for the traffic stop, Jeramey was asked for consent to search the vehicle to which he agreed stating it wasn't his. Also, while speaking with Jeramey, he stated that he is a sex offender and currently on probation for his charges. This was confirmed via teletype that Jeramey is labeled as a high risk sexual offender with an entry date of 06/13/2024 and a release date of 06/10/2029. During a search of the vehicle, deputies located an additional Florida drivers license issued to Jeramey. It was determined that the originally provided license does not have Jeramey's Florida Sex Offender Registry designation listed on it per Florida State Statute (322.212.5c). Additionally, Jeramey told deputies that he recently started a new job (04/15/2025) working for "Jay's Painting" out of Jonesville and has been driving his wife's vehicle (the vehicle he was stopped in during the above-mentioned traffic stop). Due to the above information, I consulted with both Alachua County Sheriff's Office (ACSO) Detective R. Depete whom is our sexual offender detective as well as Jeramey's probation officer (Sharon Dixon out of Gainesville's main office). Both of which confirmed that Jeramey has not provided his new employment nor the vehicle to his FDLE sexual offender registry.

Deputies also spoke with Jeramey's wife, whom is the registered owner of the vehicle, and confirmed that he has been using the vehicle regularly since being released on probation and that he has been working for "Maco Painting".

Post Miranda Jeramey stated that he drives his wife's vehicle from time to time when he is running late for his 2200 hours curfew and was unaware that he has to provide this on his registry as it is not registered to him. He also stated that he was unaware his license has to has his designation on it, stating he was never told this. Jeramey confirmed that he was provided the FDLE Sexual Predator/Offender Registration Form packet upon released, to which he filled out with his probation officer and signed stating he was aware of all stipulations. An electronic version of the packet was provided to me by Det. R. Depete and shows that Jeramey did not provide a place of employment nor any vehicles. On page 6 of the packet, it clearly shows that Jeramey signed the packet on 12/13/2024 confirming he understood all set forth stipulations.

Given the above information, Jeramey is being charged with one count of felony sexual predator/offender possession of driver's license without designation (F.S.S. 322.212.5c), one count of felony failure to report changes to employment information (F.S.S. 943.0435.4e2) and one count of felony sexual offender failure to report change in vehicles owned (F.S.S. 943.0435.2b3).
