PROSECUTIVE SUMMARY - CONTINUED

The DEF then throws the dog back onto the ground (concrete surface), and hits the dog again on the head. The DEF then walks the dog down the stairs and intentionally flicks off the RING doorbell camera. WIT (DEF's neighbor), also stated that on multiple occasions she has witnessed the DEF "beat" the same dog with a large looking stick during the dogs walks.

The DEF first agreed to speak with me over the phone, and admitted to hitting his dog because it peed on his floor. While under arrest, the DEF made multiple spontaneous statements admitting to hitting and striking the dog because he was mad and was late for work. Animal control responded to take ownership of the dog and assess for possible internal injuries.

The DEF was identified by FL DL, WIT, and RING surveillance video.
