OCA: 02-21-017155 Gainesville Police Department NARRATIVE On Tuesday 11/30/2021 at approximately 1520 hours, I responded to the Forest Pines Neighborhood at in reference to an Armed Disturbance. I was in a patrol uniform and driving a marked patrol vehicle (#4420) while assigned as the Gainesville Housing Authority Officer. It was relayed via dispatch that a subject was spraying a flame thrower at the victim's. OFC Marcotte arrived on scene first and relayed via radio that the flame thrower was no longer being used. Upon my arrival the parties were separated and OFC Marcotte was speaking with Andre Abrams 03/11/1964, the owner of the flame thrower. I am familiar with Abrams and have spoken to him in the past about his ongoing issues with the neighbors parking across the street in front of his driveway. Abrams has used the flame thrower to intimidate neighbors in the past but no charges were ever filed. After a previous incident involving the flame thrower I spoke to Abrams and warned him that it could get him in trouble if he used it towards someone and they were in fear. During this incident I first spoke with the other half of the disturbance since OFC Marcotte was with Abrams. I first interviewed . She stated she was sitting in the driver`s seat of her vehicle like she does every day after school with two friends when one of the friends stated, he has the fire thing. Initially was not in fear because Abrams is known to use it in the street but usually goes away from where she was parked. She stated he sprayed the flames next to her vehicle making it impossible for her to exit out of the driver's door. She told him you better not burn up my car. He then sprayed the flames higher towards the vehicle. thought her vehicle caught fire and was in fear of being burned so she jumped over the center console into the passenger's seat, got out of the vehicle and ran away. . She was sitting in the front passenger's seat. confirmed the account given by I then interviewed

I read Abrams his Miranda Rights from a standard Miranda card issued by GPD. Abrams stated he has had ongoing issues with the parking and came outside with his flame thrower to use it. He admitted to spraying the flame thrower near the vehicle but denied targeting the victims. He stated if he wanted to burn the vehicle, he could have. I requested to review his surveillance cameras. Initially he was hesitant but then showed OFC Marcotte and me a few select video clips. In the video it was clear he was spraying the flame thrower within a few feet of the victim's vehicle. The flames shot out approximately 20 feet. Abrams sprayed the flames multiple times towards the vehicle with the victims inside of it and sprayed the roadway multiple times leaving burn marks within approximately five feet of the vehicle.

Abrams was identified by his FL DL and charged with three counts of aggravated assault.
