On 01-30-2025 at approximately 1800 hours, I responded to [REDACTED] (Arredondo) in regards to an assault/battery call.

Upon arrival on scene, I came in contact with the caller, [REDACTED] [REDACTED] explained at approximately 30 minutes prior to the call he [REDACTED] were enjoying the evening in the neighborhood. [REDACTED]

was driving around a Pink in color battery powered ride on Jeep.

When [REDACTED] and [REDACTED] circled the block and got in front of [REDACTED] observed a white male wearing shorts, a red shirt and ballcap standing outside of the chain link fence for the property. As [REDACTED] and [REDACTED] continued going around the neighborhood block and down [REDACTED] to the north, Michael Stephens ran from where he was standing outside of the fence towards Thomas and [REDACTED]. As Michael approached [REDACTED] and [REDACTED], he stated "How are you going to bring your [REDACTED] here to come get me. I'm going to take you". Michael then got within 3 feet of [REDACTED] and [REDACTED] as he lunged for and attempted to grab the battery powered Jeep and [REDACTED] with his hands. [REDACTED] began to cry and scream something to the effect of "he tried to grab me" while driving back home. This caused substantial emotional damage to [REDACTED]. She believed that she was going to be kidnapped by a grown adult that she has never met and does not know. Michael began to yell profanities at [REDACTED] while stepping towards him. Michael threw one closed fist punch towards [REDACTED] which missed. At the time of the attempted punch, Michael had the means, intent and ability to strike [REDACTED] in the face. [REDACTED] believed that if he did not get away, Michael was going to batter him, and take his [REDACTED]. [REDACTED] then went back home to comfort [REDACTED].

[REDACTED] informed law enforcement that he wanted to move forward and pursue charges in this case. I responded to [REDACTED] St to speak with Michael. With the assistance of Michael's mother, he walked outside of the fence to speak with Deputies. At the time, I had a lawful reason to detain Michael for the on-going criminal investigation concerning the crimes alleged against him. I approached Michael and instructed him to "turn around" while simultaneously grabbing towards his arm. Michael began to back away and when I grabbed him, he stated "I would not do that" while tensing his body and resisting efforts to be lawfully detained in the performance of my duties. I grabbed a hold of Michael's t-shirt and placed him on the ground. Michael continued to tense his arms in an effort to not be handcuffed. Michael was eventually handcuffed behind the back.

Michael was placed under arrest and is being charged with one count of FSS Simple Assault-784.011.1- Intent threat to do violence, one count of FSS 843.02- Resisting without violence and one count of FSS 827.03.2C- Child abuse without great bodily harm. While transporting Michael to the Alachua County Jail, Michael made multiple statements of threats towards me. The statements he made are "I will fuck you up", "make sure you put your name on the paperwork: I won't take your head off, but you deserve to have your head taken off" and "you are fixing to pay for what you've done, everything that you do in the dark will come to light"

Michael has 4 prior battery convictions out of Alachua County; 011999MM003732XXXAXX- Guilty 02-19-1998, 01199MM003732XXXAXX- Guilty 10-06-1999, 012003MM006494XXXAXX- Guilty 7-9-2003, 012008MM005475XXXAXX- Guilty 8-6-2008 and 012022CF001423XXXAXX- Guilty 11-21-2022. Michael has one prior resisting without violence conviction out of Alachua County- 011997MM011659XXXAXX- Guilty 02-19-1998.
