County Sheriff's Office (ACSO), I received an email from Deputy Tory Vaughan from the St. Johns County Sheriff's Office (SJCSO in regards to Patrick Victor Sheridan Jr. who is a designated sexual offender in the State of Florida.

The email stated Sheridan registered as a sexual offender with the SJCSO in March 2025 and also registered in Alachua County, FL in February 2025. SJCSO was never notified Sheridan would be moving to their jurisdiction. Each time Sheridan has registered as a sexual offender, he lists his residency status as "Transient" on the FDLE Sexual Predator/Offender Registration Form. Furthermore, Deputy Vaughan advised in the email it appeared Sheridan absconded from his registration responsibilities when he was in Orange County, FL; however, Sheridan's whereabouts were never followed up with Orange County. From herein Sheridan will now be referred as the defendant.

I conducted a query of the defendant in the FDLE Sexual Offender and Predator System (SOPS) which accessed by law enforcement and reviewed the following information: On February 27, 2003, the defendant was designated a sexual offender by the competent authority of the court in Putnam County, Florida following a conviction of Lewd or Lascivious Conduct Victim Under 16 Years Old by Offender 18 Years or Older per FSS 800.04(6)(b); Putnam County case number: 54-2002-CF-001120. Due to the defendant's designation as a sexual offender he is required to register for life in the State of Florida, bi-annually on his birthday month (October) and six (6) months thereafter (April).

The defendant last registered as a sexual offender with the ACSO on February 19, 2025. At registration he provided primary transient address of Ulmerton Rd. / 49th St. Clearwater, Pinellas County, Florida and a secondary transient residence of 111 E. University Ave. Gainesville, Alachua County, Florida. Included on the FDLE Sexual Predator/Registration Form was the following language under the "NOTICE OF SEXUAL PREDATOR AND SEXUAL OFFEDNER OBLIGATIONS" section of the document:

"As a sexual predator (F.S. 775.21) or sexual offender (F.S. 943.0435; 944.607; or 985.4815) I understand that I am required by law to abide by the following:

At registration, I MUST provide the following information to the department: address of all permanent and legal residences or address of any current temporary residences, within this state or out of state, including a rural route address and a post office box; any transient residence within this state; address, location, description and dates of any current or known future temporary residence within this state or out of state;

Transient residence means a county where I live, remain, or am located for the purpose of abiding, lodging, or residing for a period of 3 or more days in the aggregate during a calendar year and which is not my permanent or temporary address. The term includes, but is not limited to, a place where I sleep or seek shelter and a location that has no specific street address. For the purpose of calculating a transient residence under this paragraph, the first day that I live, remain, or am located in a county for the purpose of abiding, lodging, or residing is excluded and each subsequent day is counted. A day includes any part of a calendar day.

If I vacate a permanent, temporary, or transient residence, and do not have another permanent, temporary, or transient residence, I MUST report in person to the sheriff's office in the county where I am located within 48 hours. I must specify the date in which I intend to or did vacate the residence, provide or update all information required mentioned above, and provide an address for the residence or other place where I am or will be located during the time. I fail to establish or maintain a permanent or temporary residence. (FSS 943.0435(4)(b)(1) FAILURE TO REPORT THIS INFORMATION WITHIN 48 HOURS IS A THIRD-DEGREE FELONY"

Upon further review of the defendant's FDLE Sexual Predator/Registration Forms, on March 20, 2025, the defendant registered in St. John's County, FL however, he never notified ACSO he intended on leaving Alachua County, FL nor did he provide a permanent, temporary, or transient address when he vacated his address from 111 E. University Ave. Gainesville, FL. The defendant does not have a contact telephone number listed to be contacted. The defendant has been charged with one (1) count of Failure to Report After Vacating Residence per FSS 943.0435(4)(b)(1).
