
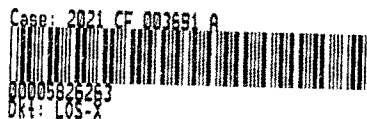


To Whom it may Concern,

I have known Mr. Andre Abrams, Sr. for over eight years. As a longtime resident and Community Liaison for Duval Front Porch organization, I am called on very often for assistance. Even though, I did not know Mr. Abrams and his wife at the time, I observed and admired their coming and going or involvement with their children. He would wait for his children at the bus stop everyday; morning and afternoon in order to protect his children. I was so very impressed to see a father looking out for his family, which is not often seen in our neighborhood. Being a former educator and from a longtime family of educators in this county, we have seen far too often parents not involved with their children education or livelihood.

Then, some years ago, while their son was in middle school, he was being bullied and was in trouble, unjustly for fighting back in self defense. Mr. Abrams came to my home asking for my help and we have remained friends and we and other community residents have often discussed the lack of police enforcement and/or protection in our neighborhood. I am retired from the City of Gainesville as a Supervisor and served for nine years on the City of Gainesville Police Advisory Board and many other Boards and would talk about the inequities of protection in addition, I make many calls to the Emergency Center for help; the problems never end. On April 18, 2021, according to GPD, I had over 23 rounds of gunshots fired within 50 feet of my home and two homes were struck and at the age of seventy, I had to crawl to the opposite end of my home for safety.

I know Mr. Abrams to be a very pleasant, caring, responsible, honest and a dependable person with a passion for fairness. He is a wonderful family man and is needed by his wife and children; far too many households are lacking fathers. This legal mishap is very unfortunate and is not reflective in any way of the wonderful role model that he is to his family and our community.

It is my prayer and hope that he is allowed by this Legal System to continue to be the protective husband, father and community member that he so desires and as I (we) know him to be.



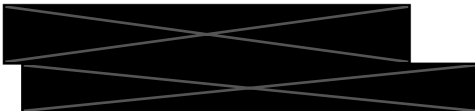

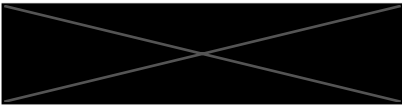
To Whom it May Concern:

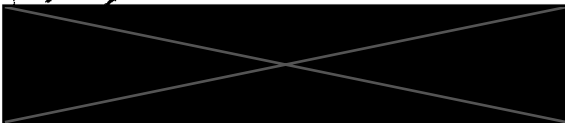
We have known Adre Abreu, Sr. for quite some time. He has always displayed around us good christian attributes and values.
